The purpose of this inspection was to conduct a Complaint inspection.

During the course of the inspection, the inspector(s) spoke with with the resident, a family member, Personal Support Workers (PSW), Registered Practical Nurses (RPN), the Assistant Director of Care (ADOC), the Director of Resident and Family Services and the Administrator.

In addition the inspector(s) conducted a tour of the home, observed lift transfer practice via a demonstration of sling/lift procedure as well as observed multiple transfers of residents including a transfer requiring use of a lift.
