Findings/Faits sayants :

1. On June 21 and 22, 2011 the inspector spoke with several residents who confirmed they disliked the time in the morning they were being woken and gotten up by staff. A management directive to night shift staff required several residents to be gotten up, provided morning care, dressed and brought to the lounge areas before the end of shift at 0600 hrs.
