The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): November 24, 2015

An inspection (2015-201167-0006) was previously conducted March 10-April 17, 2015 at which time an order (#002) was issued for failing to complete resident clinical assessments on all residents who used a bed rail and to ensure that steps were instituted to mitigate any risks to residents if the bed rail posed any identified entrapment risks. For this follow-up inspection, the conditions in the order were met and the order was cleared.

During the course of the inspection, the inspector(s) spoke with the administrator and resident care co-ordinators regarding their bed safety program.

During the course of the inspection, the inspector toured resident home areas on both the north and south towers and observed whether residents were in bed with bed rails in use, reviewed the home's bed entrapment policies and procedures, clinical assessment checklist and 7 randomly selected resident health care records (plan of care for bed rail use).
