The licensee failed to ensure that a resident exhibiting altered skin integrity was reassessed at least weekly.

The resident was assessed by the registered nursing staff and again one week later, however both assessments were incomplete with no identification of the location or any other characteristics of the wound, treatment, pain, infection, exudate etc. There was no other wound assessment completed and there should have been one other assessment to indicate the wound was healed. This was verified by the Clinical Manager.

**Sources:** review of the resident's Skin & Wound Assessments, electronic Treatment Administration Records and progress notes, and staff interview with the Clinical Manager and Administrator.

## **NOTICE OF RE-INSPECTION FEE**

Pursuant to section 348 of O. Reg. 246/22 of the Fixing Long-Term Care Act, 2021, the licensee is subject to a re-inspection fee of \$500.00 to be paid within 30 days from the date of the invoice.
