**WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6.
Plan of care**

Specifically failed to comply with the following:

s. 6. (7) The licensee shall ensure that the care set out in the plan of care is provided to the resident as specified in the plan. 2007, c. 8, s. 6 (7).

Findings/Faits saillants :

1. The licensee has failed to ensure that the care set out in the plan of care was provided to the resident as specified in the plan.

An incident occurred which triggered assessments and interventions to be completed for an identified Resident.

Three out of four assessments or interventions were not completed fully for the allotted time frame.

An interview with a staff member indicated all assessments needed to be completed in full and verified the incomplete assessments for the identified Resident.

The staff member verified the expectation of the home was to ensure all assessments were completed and that care set out in the plan of care was provided to the Resident as specified in the plan [s. 6. (7)]

Additional Required Actions:

***VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2)
the licensee is hereby requested to prepare a written plan of correction for
achieving compliance to ensure that the care set out in the plan of care is provided
to the resident as specified in the plan, to be implemented voluntarily.***
