**Findings:**  
1. The Missing Resident Policy in the Emergency Manual was not complied with.

**Additional Required Actions:**  
VPC - pursuant to the *Long-Term Care Homes Act, 2007*, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance, related to ensuring policies are complied with, to be implemented voluntarily.
