The purpose of this inspection was to conduct a Complaint inspection.
During the course of the inspection, the inspector(s) spoke with the Acting Executive Director, the former Executive Director, the RAI- Coordinator, 4 Registered Practical Nurses, 4 Personal Support Workers, and 1 Housekeeper.
During the course of the inspection, the inspector(s) confirmed staffing levels on all 5 Resident Home Areas (RHA), observed breakfast service, and care provided pre and post meal to residents; interactions between staff and residents, reviewed staffing practices and contingency plans should tub baths and showers not be completed on a shift.
