**The purpose of this inspection was to conduct a Critical Incident System inspection.**

**This inspection was conducted on the following date(s): November 8, 9, and 14-16, 2018.**

**The inspection included:**

Log #027481-18 (CIS 2982-000028-18) regarding a fall with injury and transfer to hospital.

Log #012038-18 (CIS 2982-000020-18) regarding a fall with injury and transfer to hospital,

Log #024523-18 (CIS 2982-000026-18) regarding a fall with injury and transfer to hospital, and

Log #019254-18 (CIS 2982-000025-18) regarding alleged resident to resident abuse.

**During the course of the inspection, the inspector(s) spoke with residents, Personal Care Providers (PCP), Registered Practical Nurses (RPN), Registered Nurses (RN), the Clinical Resource Nurse (CRN), the Assistant Director of Care (ADOC), a physiotherapy assistant, the Clinical Nurse Manager (CNM), and the Administrator.**

**In addition, observations of resident care and service delivery on multiple units were completed. A review of electronic records, investigation documentation and relevant Long-Term Care home policies including Falls Prevention and Management Program and Resident Safety - Abuse was also conducted.**
