During the course of the inspection, the inspector(s) spoke with residents, family, Personal Care Providers (PCP), Registered Practical Nurses (RPN), Registered Nurses (RN), the Clinical Resource Manager (CRM), Registered Nurse managers, the RAI Coordinator, the Assistant Director of Care (ADOC), the Director of Care (DOC), the Family Care Coordinator (FCC), the Recreation and Volunteer Coordinator, the Director of Nutrition and Environmental Services and the Administrator.
