This inspection was completed as a result of a complaint IL-38713-LO regarding concerns about resident care and a critical incident report CI 3037-000029-15 regarding staff to resident abuse.

During the course of the inspection, the inspector(s) spoke with the Administrator, the Director of Nursing Care, the Neighbourhood Coordinator, the resident, the resident's Power of Attorney, two Registered Staff members, two Personal Support Workers and the Physiotherapist. The Inspector also reviewed a residents clinical record, the homes policies regarding abuse/neglect and falls, a critical incident report, the homes internal investigative reports and observed general and specific care.
