**WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6.  
Plan of care**



**Specifically failed to comply with the following:**

**s. 6. (1) Every licensee of a long-term care home shall ensure that there is a written plan of care for each resident that sets out,**

**(a) the planned care for the resident; 2007, c. 8, s. 6 (1).**

**(b) the goals the care is intended to achieve; and 2007, c. 8, s. 6 (1).**

**(c) clear directions to staff and others who provide direct care to the resident. 2007, c. 8, s. 6 (1).**

**s. 6. (7) The licensee shall ensure that the care set out in the plan of care is provided to the resident as specified in the plan. 2007, c. 8, s. 6 (7).**

**s. 6. (9) The licensee shall ensure that the following are documented:**

**1. The provision of the care set out in the plan of care. 2007, c. 8, s. 6 (9).**

**2. The outcomes of the care set out in the plan of care. 2007, c. 8, s. 6 (9).**

**3. The effectiveness of the plan of care. 2007, c. 8, s. 6 (9).**

**Findings/Faits saillants :**

1. The licensee has failed to ensure that the plan of care set out clear direction to staff and others who provided direct care to the resident.

Resident #001 used a tilt wheelchair. The written plan of care included documentation regarding the fact that the chair is a Personal Assistive Device, but did not provide direction to staff regarding the degree of tilt of the chair, the frequency with which the chair was to be tilted, or times that the resident would have benefited from having the chair tilted.

During interviews with Personal Support Workers, they stated that they do not reference the written plan of care. They stated that they receive information from shift report, the Personal Care Profile - Quarterly that was located in front of the resident's flowsheet and from their co-workers.

The Personal Care Profile did not indicate that Resident #001 used a tilt wheelchair. Specific instructions regarding positioning were not indicated on the profile. [s. 6. (1) (c)]

2. Resident #001 experienced a significant change in mobility status.

Following treatment by a physician, specific instructions were ordered. On three occasions, the inspector observed Resident #001 and these instructions were not implemented.

[s. 6. (7)]

3. The licensee failed to ensure that the provision of the care set out in the plan of care was documented.

The plan of care for Resident #001 provided direction for bathing preferences.

A review of Resident #001's medical record revealed that on two occasions, baths were not documented. A review of the progress notes did not provide reasons for the missed bath, or direction for re-scheduling.

**WN #2: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 3.  
Residents' Bill of Rights**

**Specifically failed to comply with the following:**

- s. 3. (1) Every licensee of a long-term care home shall ensure that the following rights of residents are fully respected and promoted:**
- 4. Every resident has the right to be properly sheltered, fed, clothed, groomed and cared for in a manner consistent with his or her needs. 2007, c. 8, s. 3 (1).**

**Findings/Faits saillants :**

1. The Licensee has not ensured that every resident has the right to be properly cared for in a manner consistent with his or her needs. [s. 3. (1) 4.]

2. During interviews, it was confirmed that Resident #001 experienced long periods of waiting for toileting.

On two specific dates, it was confirmed by interview that Resident #001 waited for periods of 45 minutes or longer after requesting to be toileted.

On two occasions, it was confirmed by interview that meals were not given to Resident #001 until it was noted and requested by caregivers. [s. 3. (1) 4.]
