Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA. WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 131. Administration of drugs

Specifically failed to comply with the following subsections:

s. 131. (1) Every licensee of a long-term care home shall ensure that no drug is used by or administered to a resident in the home unless the drug has been prescribed for the resident. O. Reg. 79/10, s. 131 (1).

Findings/Faits saillants :

1. The licensee has not ensured that no drug is used by or administered to a resident in the home unless the drug has been prescribed for the resident.

Inspector reviewed Critical Incident documentation and corresponding health care records which document an incident where resident 001 was given another resident's medications. The resident was transferred to hospital for assessment. Inspector interviewed staff members S-004, S-005, S-006 and S-007 who confirmed that resident 001 was administered another resident's medications and was transferred to hospital for assessment. [O. Reg. 79/10, s. 131 (1)].

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that no drug is used by or administered to a resident in the home unless the drug has been prescribed for the resident, to be implemented voluntarily.
