The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): July 29, 30, 31, August 4 & 5, 2015.

This inspection was related to falls management and prevention, responsive behaviours and prevention of abuse and neglect.

During the course of the inspection, the inspector(s) spoke with the Director of Care, three Registered Practical Nurses, four Personal Support Workers, one Neighbourhood Coordinator, one Recreation Aide, a Reverend and two Residents.

During the course of the inspection, the inspector(s) reviewed nine resident clinical records including internal incident reports, 18 Critical Incident System reports, the homes policies related to prevention of abuse and neglect and responsive behaviours and 2014/2015 staff training/education records related to prevention of abuse and neglect.

During the course of the inspection, the inspector(s) observed staff/resident interactions, resident/resident interactions and two resident rooms.
