**Non-compliance with: O. Reg. 246/22, s. 140 (1)**

Administration of drugs

s. 140 (1) Every licensee of a long-term care home shall ensure that no drug is used by or administered to a resident in the home unless the drug has been prescribed for the resident. O. Reg. 246/22, s. 140 (1).

The license has failed to ensure that no drug was used by or administered to a resident unless the drug had been prescribed for the resident when a resident was administered a specified therapy for three days in March 2025 without a physician's order for administration.
