**The purpose of this inspection was to conduct a Director Order Follow Up inspection.**

**The following Director Order Follow Up intake was inspected during this inspection:**

**Log #011149-21 related to Director Order (DO) #001 from Previous Inspection #2021\_886630\_0019 regarding Long-Term Care Homes Act (LTCHA), 2007, section (s.) 19 (1) with a Compliance Due Date (CDD) of July 16, 2021.**

**During the course of the inspection, the inspector(s) spoke with the Administrator, the Director of Care (DOC), the Assistant Director of Care (ADOC), the Quality Improvement Coordinator, Registered Nurses (RNs), Register Practical Nurses (RPNs), Personal Support Workers (PSWs) and residents.**

**A follow up inspection to a Director Order (DO#001 served on 2021-07-14 concluded that the Director Order was complied with (s. 19. (1)).**

**The Inspector also observed residents and the care provided to them, and reviewed residents clinical records, the home's incident reports, and relevant policies, procedures and staff training records.**

**This inspection was conducted concurrently with Critical Incident System Inspection #2021\_788721\_0005. An Infection Prevention and Control (IPAC) observational checklist was completed and cooling and air temperature requirements were reviewed as part of this inspection.**
