WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 31. Nursing and personal support services Specifically failed to comply with the following subsections:

## s. 31. (3) The staffing plan must,

- (a) provide for a staffing mix that is consistent with residents' assessed care and safety needs and that meets the requirements set out in the Act and this Regulation;
- (b) set out the organization and scheduling of staff shifts;
- (c) promote continuity of care by minimizing the number of different staff members who provide nursing and personal support services to each resident;
- (d) include a back-up plan for nursing and personal care staffing that addresses situations when staff, including the staff who must provide the nursing coverage required under subsection 8 (3) of the Act, cannot come to work: and
- (e) be evaluated and updated at least annually in accordance with evidence-based practices and, if there are none, in accordance with prevailing practices. O. Reg. 79/10, s. 31 (3).

## Findings/Faits saillants:

1. As evidenced during a review of the Day Summary Reports and confirmed by the Director of Care, the following shifts were not staffed:

December 9, 2011

One Registered Nurse - 1500-1900

One Personal Support Worker - 1430-2230 and one Personal Support Worker - 2230-0630

December 10, 2011

One Registered Nurse - 1500-1900

One Registered Practical Nurse - 0700-1500

One Personal Support Worker - 0630-1430 and one Personal Support Worker - 1430-2230

December 11, 2011

One Registered Practical Nurse - 0700-1500

Two Registered Practical Nurses - 1500-2300

One Personal Support Worker - 0630-1430 and Two Personal Support Workers - 1430-2230

The home's staffing plan is incomplete and does not adequately include a back-up plan for nursing and personal care staffing that addresses situations when staff cannot come to work.

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure there is a complete written staffing plan for nursing and personal support services that includes a back-up plan for nursing and personal care staffing that addresses situations when staff cannot come to work, to be implemented voluntarily.
