WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 231. Resident records

Every licensee of a long-term care home shall ensure that,

**(a) a written record is created and maintained for each resident of the home;
and**

(b) the resident's written record is kept up to date at all times. O. Reg. 79/10, s. 231.

Findings/Faits saillants :

1. The licensee failed to ensure that the resident's written record is kept up to date at all times as evidenced by:

On May 7, 2014, a one month review of clinical records for identified residents revealed deficiencies in documentation.

The deficiencies in documentation were confirmed by the RAI Coordinator and the Director of Care.

The Administrator confirmed the home's expectation that the resident's written record is kept up to date at all times. [s. 231. (b)]

Additional Required Actions:

***VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2)
the licensee is hereby requested to prepare a written plan of correction for
achieving compliance to ensure the resident's written record is kept up to date
at all times, to be implemented voluntarily.***
