s. 39 (1) Every licensee of a long-term care home shall ensure that each resident of the home receives preventive and basic foot care services, including the cutting of toenails, to ensure comfort and prevent infection.

The licensee has failed to ensure that a resident received preventative and basic foot care services to ensure comfort and prevent infection.

A resident's plan of care indicated foot care services be provided at a specified frequency, however, resident did not receive foot care at the required frequency as per their plan of care.
