Inspection Summary/Résumé de l'inspection



The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): April 16, 2015

The inspection was in follow up to a Compliance Order (CO #001) issued as a result of follow up inspection #2015_346133_0001, conducted in January 2015. The CO is related to resident accessible doors that lead to non-residential areas. Over the course of the inspection, the inspector observed all such doors to be kept closed and locked when not supervised. The CO is therefore complied as a result of this follow up inspection.

During the follow up inspection, the inspector also noted that the home's main exit door, in the Houses building, is now locked at all times. This pertains to a second Compliance Order (#002), issued as a result of follow up inspection #2015_346133_0001, conducted in January 2015. The CO is also related to door alarms, and is not due until June 8th, 2015. A follow up inspection for CO #002 will occur following the compliance date.

During the course of the inspection, the inspector(s) spoke with the acting Administrator, the Facilities Supervisor, registered and non-registered nursing staff
