The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): September 22 and 23, 2015.

This inspection was related to CI-3047-00021-15 and CI-3047-000022-15 regarding allegations of abuse and done concurrently with Follow up inspection #012786-15.

During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care, two Registered staff members, a Personal Support Worker, a Personal Caregiver and three Residents.

The inspector also toured a home area, reviewed identified resident clinical records, the home's internal investigation notes and relevant training records.

The following Inspection Protocols were used during this inspection: Prevention of Abuse, Neglect and Retaliation

WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 221. Additional training — direct care staff

Specifically failed to comply with the following:

- s. 221. (2) The licensee shall ensure that all staff who provide direct care to residents receive the training provided for in subsection 76 (7) of the Act based on the following:
- 1. Subject to paragraph 2, the staff must receive annual training in all the areas required under subsection 76 (7) of the Act. O. Reg. 79/10, s. 221 (2).

Findings/Faits saillants:

1. The licensee has failed to ensure that all staff who provided direct care to residents, received annual training in abuse recognition and prevention.

On a specified date, an identified resident expressed a complaint regarding care to a Registered staff member.

On another date, a staff member reported care concerns affecting two other identified residents to the Director of Care.

A review of the Critical Incident reports submitted by the home revealed that management planned on holding mandatory abuse prevention training for all Personal Support Worker staff to attend.

A review of the home's Education Plan for 2015, dated December 2014, revealed the home had a scheduled plan for monthly education sessions. Zero Tolerance of Abuse and Abuse Recognition and Prevention training was scheduled for May 2015. The Director of Care acknowledged that training was not done.

In an interview, two direct care staff acknowledged that the only training they have received was in August 2014, when the home first opened. This information was verified by the Director of Care.

The Director of Care acknowledged that the expectation was that staff who provide direct care to residents are to receive annual training in abuse recognition and prevention. [s. 221. (2) 1.]

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that all staff who provide direct care to residents receive annual training in Abuse recognition and prevention, to be implemented voluntarily.
