The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): May 4, 2017

A Critical Incident System inspection was conducted related to an incident of alleged staff to resident abuse.

During the course of the inspection, the inspector(s) spoke with Administrator, Director of Care, Social Worker, Registered Nurse, Registered Practical Nurse, Food Service Supervisor, Clinical Coordinator, Personal Support Worker and a resident.

The Inspector also reviewed the internal investigation notes, employee file, resident's clinical records, relevant policies and procedures and observed resident/staff interactions.

The following Inspection Protocols were used during this inspection: Prevention of Abuse, Neglect and Retaliation

WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 129. Safe storage of drugs

### Specifically failed to comply with the following:

- s. 129. (1) Every licensee of a long-term care home shall ensure that,
- (a) drugs are stored in an area or a medication cart,
  - (i) that is used exclusively for drugs and drug-related supplies,
  - (ii) that is secure and locked,
- (iii) that protects the drugs from heat, light, humidity or other environmental conditions in order to maintain efficacy, and
- (iv) that complies with manufacturer's instructions for the storage of the drugs; and O. Reg. 79/10, s. 129 (1).
- (b) controlled substances are stored in a separate, double-locked stationary cupboard in the locked area or stored in a separate locked area within the locked medication cart. O. Reg. 79/10, s. 129 (1).

## Findings/Faits saillants:

1. The licensee failed to ensure that drugs were stored in an area or medication cart that was secured and locked.

During an inspection, a locked medication cart, in an identified area of the home, was observed to be left unattended, with six strip packaging pouches on top of the cart, containing a variety of medications. No registered staff member was present. The medications were accessible to residents as there were nine residents seated at dining room tables and two other residents walked passed the medication cart.

The Food Service Supervisor also observed the medications on top of the unattended medication cart.

The medications were delivered to the Director of Care.

During an interview, the Director of Care said the medications should not have been left on top of the medication cart, as it posed a potential risk to residents and medications were to be kept in the locked medication cart, at any time when the cart was unattended.

The severity of this area of non-compliance was 2 - minimal harm or potential for actual harm, the scope was 1- isolated and the compliance history was 3 - previous related non - compliance, as a Voluntary Plan of Correction was issued in October 2014, under Inspection # 2014\_263524\_0035. ### Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that drugs were stored in an area or medication cart that was secured and locked, to be implemented voluntarily.
