During the course of the inspection, the inspector(s) spoke with the Chief Administrative Officer (CAO - Head Office), the Human Resources Manager, the Administrator, a Registered Nurse and Activity Aides.

Also during the course of the inspection, the inspector reviewed Activation calendars, related human resources records including; the Prince Edward County job information questionnaire and an offer of employment.

1. The Licensee has failed to ensure that there is a designated lead for the recreational and social activities program.

The Ministry of Health and Long Term Care received a complaint on a specified date related to the licensee not having a designated lead for the recreational and social activities program since March 2017.

During an Interview with inspector #622 on June 27, 2017, the complainant indicated the designated lead position for the recreational and social activities program (Recreation/Activity Supervisor) had been vacant since March 24, 2017. The complainant also indicated there had not been anyone filling the Recreation/Activity Supervisor position temporarily; the position had not been posted or replaced since it became vacant.

During an interview with inspector #622 on June 29, 2017, the Administrator indicated the Recreation/Activity Supervisor position had been vacant since March 24, 2017.

During separate interviews with inspector #622 on June 30, 2017, the Administrator and the Chief Administrative Officer (CAO) indicated the position of Recreation/Activity Supervisor had not been filled or posted due to the time it had taken to modify the job description. The Administrator further indicated that on June 30, 2017 one of the homes activity aides with qualifications to perform the designated lead position had agreed to accept the designated lead for the recreation and social activities program until the position was filled permanently. Furthermore, the Administrator indicated the position of Recreation/Activity Supervisor was vacant from March 24, 2017 until June 30, 2017. [s. 66. (1)]

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure a temporary replacement is assigned to the position of Recreation/Activity Supervisor in a timely manner until the recruitment process is completed and the vacancy is filled, to be implemented voluntarily.
