The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): August 17, 2017

An inspection (2016-210169-0016) was previously conducted October 20-November 8, 2016, and two compliance orders were issued. Order #001 was issued related to bed safety and Order #002 was issued related to the home's remedial maintenance program. For this follow-up visit, the conditions laid out in both orders have been addressed.

During the course of the inspection, the inspector(s) spoke with Executive Director, Director of Care, Assistant Director of Care and Environmental Services Supervisor.

During the course of the inspection, the inspector toured all four floors, observed resident bed systems and furnishings, condition of flooring, bathroom fixtures and blinds, maintenance policies and procedures, maintenance schedules, resident clinical records and bed safety policies and procedures.

WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 15. Accommodation services

Specifically failed to comply with the following:

- s. 15. (2) Every licensee of a long-term care home shall ensure that,
- (a) the home, furnishings and equipment are kept clean and sanitary; 2007, c. 8, s. 15 (2).
- (b) each resident's linen and personal clothing is collected, sorted, cleaned and delivered; and 2007, c. 8, s. 15 (2).
- (c) the home, furnishings and equipment are maintained in a safe condition and in a good state of repair. 2007, c. 8, s. 15 (2).

### Findings/Faits saillants:

1. The licensee did not ensure that furnishings were maintained in a safe condition and in a good state of repair.

During an inspection completed on August 17, 2017, approximately 14 night tables were noted to be in poor condition in resident rooms on the second and fourth floors. The night tables, which were made of particle board with a laminate overlay, had exposed particle board along the top front edge of each night table that was very rough and could not be cleaned due to the rough material. Some night tables had several centimeters of missing laminate. An internal audit completed on June 27, 2017, reveled that the same night tables identified by the inspector were also identified by maintenance staff as being in poor condition. They were not included in the purchase of 72 night tables that were made in early June 2017. The Executive Director identified that over 100 night tables were slated for replacement in 2018 and that the remaining night tables identified during this visit would be replaced by the end of October 2017. ## Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that furnishings are maintained in a safe condition and in a good state of repair, to be implemented voluntarily.
