WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 8. Nursing and personal support services

Specifically failed to comply with the following:

s. 8. (3) Every licensee of a long-term care home shall ensure that at least one registered nurse who is both an employee of the licensee and a member of the regular nursing staff of the home is on duty and present in the home at all times, except as provided for in the regulations. 2007, c. 8, s. 8 (3).

Findings/Faits saillants:

1. The licensee has failed to ensure that at least one registered nurse who is both an

employee of the licensee and a member of the regular nursing staff of the home is on duty and present in the home at all times, except as provided for in the regulations.

- H.J. McFarland has a licensed bed capacity of 84 beds. O. Reg 79/10, s. 45 (1) 2 outlines an exception to the requirements for registered nurses, for homes with a licensed bed capacity of more than 64 beds and fewer than 129 beds as follows:
- i. in the case of a planned or extended leave of absence of an employee of the licensee who is a registered nurse and a member of the regular nursing staff, a registered nurse who works at the home pursuant to a contract or agreement with the licensee and who is a member of the regular nursing staff may be used,
- ii. in the case of an emergency (defined as an unforeseen situation of a serious nature that prevents a registered nurse from getting to the long-term care home), where the back-up plan fails, a registered nurse who works at the home pursuant to a contract or agreement between the licensee and an employment agency or other third party may be used if:
- A. The Director of Nursing and Personal Care or a registered nurse who is both an employee of the licensee and a member of the regular nursing staff is available by telephone, and
- B. A registered practical nurse who is both an employee of the licensee and a member of the regular nursing staff is on duty and present in the home.

The home's registered staff schedule was reviewed from January 1 to March 25, 2018. January 1 to February 15, 2018, RN #104 was on an extended leave of absence and these shifts were covered by agency staff members in accordance with the above outlined exceptions. An additional twenty-one shifts were covered using agency staff that were not allowable under the above exceptions for this period of time. These shifts were not the result of a planned or extended leave of absence or as a result of an emergency as defined by the legislation. The shifts covered by the agency staff were required due to the unavailability of the current registered nurses employed in the home.

The Administrator was interviewed in regards to the use of agency staff and indicated the home initially seeks to cover the shifts using the part time pool of registered nurses. When this fails, the registered staff working are offered over time. Agency staff are arranged to cover the shift when these measures fail. The Administrator stated the home is actively seeking to hire additional registered nurses. The home has successfully filled

one full time registered nurse position and to date of this inspection has resulted in a decrease in the need for agency staff. [s. 8. (3)]
