Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6. Plan of care
Specifically failed to comply with the following subsections:

- s. 6. (1) Every licensee of a long-term care home shall ensure that there is a written plan of care for each resident that sets out,
- (a) the planned care for the resident;
 - (b) the goals the care is intended to achieve; and
 - (c) clear directions to staff and others who provide direct care to the resident. 2007, c. 8, s. 6 (1).

Findings/Faits sayants :

1. 14:30

Reviewed "Personal Resident Care: Foot/Toenail Care" policy.

The plan of care does not set out clear directions to staff related to providing foot/toenail care. Due to diagnosis/history, the resident is determined to be at risk for foot/toenail problems. This is not documented in the plan of care nor the frequency of which the registered staff will inspect the feet or provide foot/toenail care.

WN #2: The Licensee has failed to comply with O.Reg 79/10, s. 8. Policies, etc., to be followed, and records
Specifically failed to comply with the following subsections:

- s. 8. (1) Where the Act or this Regulation requires the licensee of a long-term care home to have, institute or otherwise put in place any plan, policy, protocol, procedure, strategy or system, the licensee is required to ensure that the plan, policy, protocol, procedure, strategy or system,
- (a) is in compliance with and is implemented in accordance with applicable requirements under the Act; and
 - (b) is complied with. O. Reg. 79/10, s. 8 (1).

Findings/Faits sayants :

1. 14:55 - The Personal Resident Care: Foot/Toenail Care policy is not being complied with.

The plan of care for foot/toenail care is not documented in the care plan as required by the policy.

As a requirement of the same policy, there is no documented evidence on the Personal Care Providers' flowsheet that nail care was done.
