1. The licensee has failed to ensure that the long-term care home had a Director of Nursing and Personal Care.

During the inspection May 6 and 7, 2019, there was no Director of Nursing and Personal Care in the home.

In an interview with the Executive Director, they said that they have not had a Director of Nursing and Personal Care since January, 2019. They said that they have been actively recruiting for the entire time and have attempted to hire, but have been unsuccessful. They said that there is a an acting Director of Nursing and Personal Care starting on May 20, 2019.

In an interview with the Regional Director, they said that the home has not had a Director of Nursing and Personal Care since January, 2019. They said that they have been actively recruiting for the entire time and have attempted to hire, but have been unsuccessful. They said that there is a an acting Director of Nursing and Personal Care starting on May 20, 2019. They said that the Clinical Consultant is in the home once a week supporting the home in the Director of Nursing and Personal Care tasks and that some registered nurses (RN)s have been pulled from their usual duties to assist with the Director of Nursing and Personal Care tasks.

In an interview with the Clinical Consultant, they said that they provide clinical consulting services and clinical support only to the home once per week. They said that they do not oversee or have direct responsibility to the nursing staff in the home.

In an interview with an RN, they said that the home has not had a Director of Nursing and Personal Care since December 2018. They said that they are occasionally pulled from their usual registered nurse duties to complete audits and some of the Director of Nursing and Personal Care tasks, as were a couple of the other RNs, but it had been a few weeks since they have had time to complete these other tasks.

The licensee has failed to ensure that the long-term care home had a Director of Nursing and Personal Care for over four months. [s. 71. (1)]
