The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): May 29, June 2, 4 and 8, 2020.

This inspection was completed for the following:

Critical Incident Intake Log #003509-20, CIS #2628-000003-20 related to allegations of staff to resident abuse.

Critical Incident Intake Log #003513-20, CIS #2628-000004-20 related to a resident's fall.

This inspection was completed concurrently with Complaint inspection #2020_607523_0014

A Written Notification related to LTCHA, 2007 S.O. 2007, c.8, s. 24. (1) was issued in this inspection as a supporting evidence for Compliance Order #006, Inspection #2019_725522_0018, Compliance Due Date May 15, 2020.

During the course of the inspection, the inspector(s) spoke with the Administrator, Acting Administrator, Director of Care (DOC), three Registered staff members, three Personal Support Workers (PSW) and two residents.

The inspector(s) also toured the home, observed residents and care provided to them, reviewed clinical records, incident reports, investigation notes and reviewed specific policies and procedures of the home.

The following Inspection Protocols were used during this inspection: Falls Prevention Prevention of Abuse, Neglect and Retaliation

Specifically failed to comply with the following:

(a) is in compliance with and is implemented in accordance with applicable requirements under the Act; and O. Reg. 79/10, s. 8 (1).

1. The licensee has failed to ensure that any plan, policy, protocol, procedure, strategy or system instituted or otherwise put in place was complied with.

The home submitted a Critical Incident System (CIS) report on a specific date related to a resident's fall.

ONTARIO REGULATION 79/10, section 48. (1) stated "Every licensee of a long-term care home shall ensure that the following interdisciplinary programs are developed and implemented in the home:

1. A falls prevention and management program to reduce the incidence of falls and the risk of injury."

A review of the home's policy subject: Falls Prevention & Management, Policy # VII-G-30.10. dated February 2020, showed that under procedure the Nurse will complete a post falls assessment and head injury routine. The initial post-fall assessment note must include the assessment of damage to the hip joint and limited range of motion of joints. The policy also showed that appropriate lifting procedure would be performed to mobilize the resident if no injury was evident.

Staff interviews and record reviews showed that a specific staff member did not comply with the home's policy specific to assessing and transferring the resident post fall.

In an interview the DOC said that the resident had fall during the night shift, during the internal investigation they found out that the staff member did not comply with the home's policy when they assessed and transferred the resident.

The DOC said that the staff member was no longer in the home and that it was the expectation for staff to comply with the home's policies and procedures. [s. 8. (1) (a),s. 8. (1) (b)]

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that the home's Falls Prevention policy and procedure was complied with, to be implemented voluntarily.

WN #2: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 24. Reporting certain matters to Director

Specifically failed to comply with the following:

s. 24. (1) A person who has reasonable grounds to suspect that any of the following has occurred or may occur shall immediately report the suspicion and the information upon which it is based to the Director:

1. Improper or incompetent treatment or care of a resident that resulted in harm or a risk of harm to the resident. 2007, c. 8, s. 24 (1), 195 (2).

Abuse of a resident by anyone or neglect of a resident by the licensee or staff that resulted in harm or a risk of harm to the resident. 2007, c. 8, s. 24 (1), 195 (2).
 Unlawful conduct that resulted in harm or a risk of harm to a resident. 2007, c. 8, s. 24 (1), 195 (2).

4. Misuse or misappropriation of a resident's money. 2007, c. 8, s. 24 (1), 195 (2). 5. Misuse or misappropriation of funding provided to a licensee under this Act or the Local Health System Integration Act, 2006. 2007, c. 8, s. 24 (1), 195 (2).

1. The licensee has failed to comply with s. 24 (1) 2, in that a person who had reasonable grounds to suspect abuse of a resident, failed to report the alleged abuse immediately to the Director in accordance with s. 24 (1) 2 of the LTCHA.

Pursuant to LTCHA 2007, s. 152 (2) the licensee is vicariously liable for staff members failing to comply with subsection 24 (1).

The home submitted a Critical Incident System (CIS) report on a specific date related to allegations of staff to resident verbal abuse.

Staff interviews showed that the allegations were not reported to the Director immediately.

In an interview the DOC and Administrator said that the expectation was for allegations of abuse to be reported to the Director immediately. [s. 24. (1)]
