The purpose of this inspection was to conduct a Complaint inspection.

This inspection was conducted on the following date(s): May 3-7, 2021.

The following complaints were inspected during this inspection:

Two Complaints regarding allegations of resident care concerns.

A concurrent Critical Incident System Inspection #2021\_822613\_0011 was also conducted during this inspection.

During the course of the inspection, the inspector(s) spoke with Administrator (ADM), Executive Director of Care (EDOC), Directors of Care (DOCs), Behavioural Supports Ontario Registered Practical Nurse (BSO RPN), Registered Nurses (RNs), Registered Practical Nurses (RPNs), Personal Support Wokers (PSWs) and residents.

The Inspector(s) also conducted daily tours of resident care areas, observed the provision of care and services to residents, observed staff to resident interactions, reviewed health care records, and internal investigation files, and reviewed relevant policies, procedures and programs.

Findings/Faits saillants :

1. The licensee has failed to ensure that the system to provide safe medication management was complied with.

In accordance with O. Reg. 79/10, s. 114. (2.), the licensee was required to ensure that written policies and protocols were developed for the medication management system to ensure the accurate administration of all drugs used in the home.

Specifically, staff did not comply with the licensee's Medication Pass policy.

The home's Medication Pass policy, indicated that medications were to be administered following the nine rights of medication administration, including the right of refusal.

A Medication Incident Report indicated that a resident received a medication that was not consented for. A progress note indicated the resident received the medication in error.

During an interview with a RPN, they indicated that they administered the medication to the resident and that they did not check the resident's consent themselves. They further stated that there was no consent given for the medication administration.

There was increased risk that registered practical nurses were not following the licensee's medication management system and not providing safe medication management.
