**Specifically failed to comply with the following:**

**s. 131. (2) The licensee shall ensure that drugs are administered to residents in accordance with the directions for use specified by the prescriber. O. Reg. 79/10, s. 131 (2).**

**Findings/Faits saillants :**

1. The licensee failed to ensure that drugs were administered in accordance with the directions for use specified by the prescriber for resident #003.

Review of resident #003 clinical records and investigation notes indicated that the resident had an identified diagnosis, with a prescribed medication. Review of records and RPN #100's statement indicated on an identified date, at breakfast and lunch they conducted the required assessment and administered the medication both at breakfast and lunch which is not according to the directions.

Interview's with RPN #107 and RN #105 indicated that on that identified date, during the evening shift, resident #003 was discovered by RPN #107 in bed with a significant change in status. RPN #107 conducted an assessment which alerted RPN #107 to call RN# 105 and inform them of the situation, RN# 105 called the physician and retrieved an order to administer a medication to the resident. The medication was immediately administered, followed by an assessment by the registered staff, physician was notified and ordered to transfer resident to hospital. Resident returned back to home the same day with no changes to medication and stabilized.

Interview with Acting Nurse Manager indicated that RPN#100 had failed to read the entire medication order prescribed to the resident, they indicated that RPN#100 should have held the medication for breakfast and lunch based on their assessment. They further indicated that they also failed to complete an independent double-check, where registered staff are required to ensure that two clinicians check each component of preparing and verifying high alert medications before they are administered to any resident. They indicated that this is a high alert medication and this put the resident at risk as they had to be transferred to hospital for stabilization.
