Non-compliance with: FLTCA, 2021, s. 107 (3), and LTCHA, 2007, s. 104 (3)

The licensee has failed to ensure that there was written permission from the Director for beds not to be available for occupancy for more than 14 consecutive days, and that all beds that were allowed under the license were occupied or were available for occupation.

Staff from Home and Community Care Support Services (HCSS) North East stated that they had been informed by the home that 32 beds on the Apple Orchard One unit were not available for admission due to staffing issues at the home. Staff from HCSS further stated that there were currently 59 people on wait list for the home that were potential candidates for admission.

The Administrator of the home stated that there was a 32-bed unit in the home that was currently unoccupied and had been unoccupied since September 18, 2020. The Administrator further stated that the unit remained unoccupied due to staffing issues at the home. The Administrator verified that the home did not seek written permission from the Director to have the beds unoccupied for more than 14 consecutive days, and that the beds were not currently in abeyance.
