# **INSPECTION RESULTS**

# WRITTEN NOTIFICATION: Infection Prevention and Control Lead

NC #001 Written Notification pursuant to FLTCA, 2021, s. 154 (1) 1. Non-compliance with: O. Reg. 246/22, s. 102 (15) 2

The licensee failed to ensure that a designated Infection prevention and control (IPAC) lead worked regularly in that position on site at the home, with a licensed bed capacity of more than 69 beds but less than 200 beds, at least 26.25 hours per week.

#### **Rationale and Summary**

During the home's inspection, there was an IPAC Lead who had a shared IPAC responsibility with another home. They could not fulfill the minimum hours of 26.25 hours per week.

The DOC confirmed that this position was unfilled and that the home was actively recruiting for the role.
