- 1. All doors leading to stairways and the outside of the home other than doors leading to secure outside areas that preclude exit by a resident, including balconies and terraces, or doors that residents do not have access to must be,
 - i. kept closed and locked,
- ii.equipped with a door access control system that is kept on at all times, and iii.equipped with an audible door alarm that allows calls to be cancelled only at the point of activation and,
 - A. is connected to the resident-staff communication and response system, or
- B. is connected to an audio visual enunciator that is connected to the nurses' station nearest to the door and has a manual reset switch at each door. O. Reg. 79/10, s. 9. (1).
- 2. All doors leading to non-residential areas must be equipped with locks to restrict unsupervised access to those areas by residents. O. Reg. 79/10, s. 9. (1).
- 3. Any locks on bedrooms, washrooms, toilet or shower rooms must be designed and maintained so they can be readily released from the outside in an emergency. O. Reg. 79/10, s. 9. (1).
- 4. All alarms for doors leading to the outside must be connected to a back-up power supply, unless the home is not served by a generator, in which case the staff of the home shall monitor the doors leading to the outside in accordance with the procedures set out in the home's emergency plans. O. Reg. 79/10, s. 9. (1).

Findings/Faits saillants:

1. On June 24 and 25, 2013, inspector found the door near the 1st floor main dining room to be unlocked and residents could gain access to outside areas that were not secure. Inspector was able to walk out the door and access nearby parking lots and streets. The licensee failed to ensure that all doors leading to stairways and the outside of the home other than doors leading to secure outside areas that preclude exit by a resident, including balconies and terrace, or doors that residents do not have access to must be, kept closed and locked. 1. Critical Incident System (CIS) report submitted to the Ministry of Health and Long-Term Care indicates a staff member observed in a surveillance monitor, resident #003 being abused. On June 25, 2013, inspector requested staff member #S-100 to provide the home's documentation regarding the investigation into witnessed incident of abuse. The information given to the inspector including, a copy of the CIS report, three emails from staff member #S-100 to Staff member #S-101, # S-102 and # S-103, and 4 digital print outs from the surveillance monitor system, did not support that the licensee had undertaken an actual investigation into the incident. The licensee failed to ensure that every alleged, suspected or witnessed incident of abuse, that the licensee knows of, or that is reported to the licensee, is immediately investigated. [s. 23. (1) (a)]

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that every alleged, suspected or witnessed incident of abuse, that the licensee knows of, or that is reported to the licensee, is immediately investigated, to be implemented voluntarily.

WN #5: The Licensee has failed to comply with O.Reg 79/10, s. 107. Reports recritical incidents

- 2. An unexpected or sudden death, including a death resulting from an accident or suicide. O. Reg. 79/10, s. 107 (1).
- 3. A resident who is missing for three hours or more. O. Reg. 79/10, s. 107 (1).
- 4. Any missing resident who returns to the home with an injury or any adverse change in condition regardless of the length of time the resident was missing. O. Reg. 79/10, s. 107 (1).
- 5. An outbreak of a reportable disease or communicable disease as defined in the Health Protection and Promotion Act. O. Reg. 79/10, s. 107 (1).
- 6. Contamination of the drinking water supply. O. Reg. 79/10, s. 107 (1).

Findings/Faits saillants:

1. A CIS report submitted to the Ministry of Health and Long-Term Care indicates that resident # 005 went missing from the home, sustained injury and was brought to the North Bay Regional Health Centre for assessment. The home did not notify the Director for 2 days that the resident was missing and sustained and injury. The licensee failed to ensure that the Director is immediately informed, in as much detail as is possible when a resident returns to the home with an injury or any adverse change in condition regardless of the length of time the resident was missing.

A CIS report submitted to the Ministry of Health and Long-Term Care indicates, resident # 004 was missing from the home for greater than 3 hours. The home did not notify the Director that resident # 004 was missing for more than 3 hours, will 3 days later. The licensee failed to ensure that the Director is immediately informed, in as much detail as is possible when a resident is missing for three hours or more. [s. 107. (1)]
