During the course of the inspection, the inspector(s) spoke with Chief Executive Officer (CEO), Director of Clinical Services (DOC), Manager of Human Resources, Behavioural Support Officer (BSO), Personal Support Workers (PSW), Registered Practical Nurses (RPN), and Registered Nurses (RN)/Supervisors of Clinical Services.
