## Findings/Faits saillants :

1. The licensee failed to ensure that the following rights of residents were fully respected and promoted.

Every resident has the right to designate a person to receive information concerning any transfer or any hospitalization of the resident and to have that person receive that information immediately:

In May, 2014 a Resident was transferred to a hospital. The home failed to notify the Resident's Substitute Decision Maker immediately. This was confirmed by the clinical record and the Director of Care. [s. 3. (1) 16.]

#### Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure every resident has the right to designate a person to receive information concerning any transfer or hospitalization and to have that person receive that information immediately, to be implemented voluntarily.

WN #2: The Licensee has failed to comply with O.Reg 79/10, s. 8. Policies, etc., to be followed, and records

Specifically failed to comply with the following:

s. 8. (1) Where the Act or this Regulation requires the licensee of a long-term care home to have, institute or otherwise put in place any plan, policy, protocol, procedure, strategy or system, the licensee is required to ensure that the plan, policy, protocol, procedure, strategy or system,

(a) is in compliance with and is implemented in accordance with applicable requirements under the Act; and O. Reg. 79/10, s. 8 (1).

(b) is complied with. O. Reg. 79/10, s. 8 (1).

1. The licensee failed to ensure that the plan, protocol and procedure was in place and is in compliance with and is implemented in accordance with all applicable requirements under the Act, and complied with as evidenced by:

In May, 2014 a Resident fell and was transferred to the hospital.

The Registered Staff failed to follow Emergency Protocol which would have notified other Registered Staff in the building of the incident.

This was confirmed by the internal investigation records and the Director of Care. [s. 8. (1) (a),s. 8. (1) (b)]

# Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that the plans and protocols are complied with, to be implemented voluntarily.

WN #3: The Licensee has failed to comply with O.Reg 79/10, s. 48. Required programs

Specifically failed to comply with the following:

s. 48. (1) Every licensee of a long-term care home shall ensure that the following interdisciplinary programs are developed and implemented in the home:

1. A falls prevention and management program to reduce the incidence of falls and the risk of injury. O. Reg. 79/10, s. 48 (1).

2. A skin and wound care program to promote skin integrity, prevent the development of wounds and pressure ulcers, and provide effective skin and wound care interventions. O. Reg. 79/10, s. 48 (1).

3. A continence care and bowel management program to promote continence and to ensure that residents are clean, dry and comfortable. O. Reg. 79/10, s. 48 (1).

4. A pain management program to identify pain in residents and manage pain. O. Reg. 79/10, s. 48 (1).

1. The licensee failed to ensure a pain management program was in place to identify pain in residents and manage pain:

An interview with the Director of Care revealed the Pain Management Program was not yet written. The Director of Care was drafting a plan to get the Pain Management Program operating.

This was verified with the Director of Care and the Administrator as well through the internal investigation and clinical records. [s. 48. (1)]

2. The licensee failed to ensure that a falls prevention and management program to reduce the incidence of falls and the risk of injury are developed and implemented in the home as evidenced by:

An interview with the Director of Care revealed the home does not currently have a falls prevention and management program implemented fully. This was verified through the internal investigation and clinical records. [s. 48. (1) 1.]

## Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure the required interdisciplinary programs are developed and implemented in the home, to be implemented voluntarily.
