**WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 8.  
Nursing and personal support services**

**Specifically failed to comply with the following:**

**s. 8. (3) Every licensee of a long-term care home shall ensure that at least one registered nurse who is both an employee of the licensee and a member of the regular nursing staff of the home is on duty and present in the home at all times, except as provided for in the regulations. 2007, c. 8, s. 8 (3).**

**Findings/Faits saillants :**

1. The licensee failed to comply with the LTCHA 2007, S.O. 2007, c 8,s.8(3), in that management failed to ensure that there is a least one registered nurse, who is an employee of the licensee and a member of the regular staff on duty and present at all times.

The nursing staff schedule was reviewed for the period of November 29, 2014 to February 6, 2014. It was confirmed with the Staffing Clerk and the Director of Care that there was no Registered Nurse on duty for the day shifts of November 29, December 1,15,17 and for 4.5 hours on the day shift December 29, 2014 .

Almonte Country Haven is an 82 bed Long Term Care Home. The shifts not being covered by a Registered Nurse are not a result of an emergency. The exceptions to the requirement that at least one Registered Nurse who is both an employee of the licensee and a member of the regular staff are not applicable as per O.Reg.79/10 s. 45(1) (1) [s. 8. (3)]

**Additional Required Actions:**

**VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2)  
the licensee is hereby requested to prepare a written plan of correction for  
achieving compliance to ensure that there is at least one registered nurse, who  
is an employee of the licensee and a member of the regular staff on duty and  
present at all times, to be implemented voluntarily.**
