During the course of the inspection, the inspector(s) spoke with four residents, the Administrator, Director of Nursing, Registered Dietitian, Food Service Supervisor and five Personal Service Workers.

During the course of the inspection, the inspector(s) observed morning and afternoon snack service on two resident home areas and reviewed the Resident Council and Food Council Minutes, the spring/summer menu, the list of resident food likes/dislikes and diet textures.
