WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6. Plan of care
Specifically failed to comply with the following subsections:

s. 6. (1) Every licensee of a long-term care home shall ensure that there is a written plan of care for each resident that sets out,
(a) the planned care for the resident;
(b) the goals the care is intended to achieve; and
(c) clear directions to staff and others who provide direct care to the resident. 2007, c. 8, s. 6 (1).

s. 6. (7) The licensee shall ensure that the care set out in the plan of care is provided to the resident as specified in the plan. 2007, c. 8, s. 6 (7).

Findings/Faits saillants :

- Log #00034-12 - Resident #1:
The written plan of care identifies that the resident requires assistance for transfers and provides conflicting direction related to the type of lifting device to be used to assist the resident.[s.6.(1)(c)]
- Log #00034-12 - Resident #1:
The resident's plan of care directs that the resident requires the assistance of two staff members for safe transfer. A PSW transferred the resident without assistance of another staff member, resulting in injury to the resident. The care set out in the plan of care was not provided to the resident as specified in the plan.[s.6.(7)]

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that the written plan of care for each resident provides clear direction to staff and others who provide direct care to the resident as it relates to lift and transfer needs of the resident, and to ensure that the care set out in the plan, as it relates to lifts and transfers, is provided to the resident, to be implemented voluntarily.

WN #2: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 23. Licensee must investigate, respond and act

Specifically failed to comply with the following subsections:

s. 23. (2) A licensee shall report to the Director the results of every investigation undertaken under clause (1) (a), and every action taken under clause (1) (b). 2007, c. 8, s. 23 (2).

1. Log #00034-12 - Resident #1 - related to a report of staff to resident abuse/neglect involving a verbal altercation between a staff member and the resident.
Log #000194-12 - Resident #2 - related to a report of staff to resident abuse/neglect involving the improper lift and transfer of a resident.

Investigations related to these incidents were completed and documented. At the time of the inspection, the results of the investigations and actions taken were not reported to the Director. [s.23.(2)]

WN #3: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 24. Reporting certain matters to Director

Specifically failed to comply with the following subsections:

s. 24. (1) A person who has reasonable grounds to suspect that any of the following has occurred or may occur shall immediately report the suspicion and the information upon which it is based to the Director:

1. Improper or incompetent treatment or care of a resident that resulted in harm or a risk of harm to the resident.
2. Abuse of a resident by anyone or neglect of a resident by the licensee or staff that resulted in harm or a risk of harm to the resident.
3. Unlawful conduct that resulted in harm or a risk of harm to a resident.
4. Misuse or misappropriation of a resident's money.
5. Misuse or misappropriation of funding provided to a licensee under this Act or the Local Health System Integration Act, 2006. 2007, c. 8, ss. 24 (1), 195 (2).

Findings/Faits saillants :

1. Log #000194-12 - The home was made aware of an incident of alleged staff to resident verbal abuse and a Critical Incident Report was submitted four days later. The allegation of abuse of a resident was not immediately reported to the Director. [s.24.(1)(2)]
