WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 30. General requirements

Specifically failed to comply with the following subsections:

s. 30. (2) The licensee shall ensure that any actions taken with respect to a resident under a program, including assessments, reassessments, interventions and the resident's responses to interventions are documented. O. Reg. 79/10, s. 30 (2).

Findings/Faits saillants :

1. As required by LTCHA, 2007, S.O., c.8., under s.8 and s.10, the licensee shall ensure that there is an organized program of nursing and personal support services and an organized program of recreational and social activities in the home.
- Documentation related to interventions and the resident's responses to interventions is incomplete in the following areas:
- Recreation and social activity records do not provide complete documentation related to participation in programs as observed, as reported by PSW's, registered nursing staff and program staff, and as documented in the resident's plan of care.
 - Nursing records do not provide complete documentation related to the provision of baths/showers as reported by PSW's and registered nursing staff. [r.30.(2)]
