WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6. Plan of care
Specifically failed to comply with the following subsections:

s. 6. (7) The licensee shall ensure that the care set out in the plan of care is provided to the resident as specified in the plan. 2007, c. 8, s. 6 (7).

Findings/Faits saillants :

The licensee did not ensure that the care set out in the plan of care is provided to the resident as specified in the plan. An identified resident assessed to require a restraint, did not have the restraint applied on an identified date in 2011 and as a result, sustained a fall.

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that the care set out in the plan of care is provided to the resident as specified in the plan, to be implemented voluntarily.

WN #2: The Licensee has failed to comply with O.Reg 79/10, s. 33. Bathing
Specifically failed to comply with the following subsections:

s. 33. (1) Every licensee of a long-term care home shall ensure that each resident of the home is bathed, at a minimum, twice a week by the method of his or her choice and more frequently as determined by the resident's hygiene requirements, unless contraindicated by a medical condition. O. Reg. 79/10, s. 33 (1).

Findings/Faits saillants :

The licensee of the long Term Care home did not ensure that each resident of the home was bathed, at a minimum, twice a week by the method of his her choice and more frequently as determined by the resident's hygiene and grooming requirements, unless contraindicated by a medical condition. Staff report that not all residents received a bath/shower when the home was short staffed. Clinical records and staff schedules reviewed indicate that on at least 6 occasions from July to September 2011, the home was short staffed and on these identified days, at least 14 identified residents did not receive a bath/shower as indicated in their plans of care.
