Findings/Faits saillants:

1. The licensee failed to ensure that the home complied with every directive issued, order made or agreement entered into under this Act when they failed to allow essential caregivers to visit residents inside the home.

Directive #3, dated December 7, 2020, required long-term care home licensees to balance the need to mitigate risks of COVID-19 to residents, staff and visitors with the mental, physical and spiritual needs of residents for their quality of life. It required LTC home's to have a visitor policy in place that was compliant with this Directive and was guided by applicable policies, amended from time to time, by the Ministry of LTC.

COVID-19: Visiting Long Term Care Homes policy, dated December 26, 2020, was provided to support homes in implementing the requirements in Directive #3 and the Minister's Directive to safely receive visitors while protecting residents, staff and visitors from COVID-19. It stated that if a local public health unit was in Grey zone, a maximum of 1 essential caregiver may visit a resident at a time even if the resident was self-isolating or symptomatic or the home was in outbreak. It stated that residents must be given equitable access to receive visits, consistent with their preferences and within reasonable restrictions that safeguard residents.

A complaint was received by the Ministry of Long Term Care stating that the home was not allowing essential caregivers to visit inside the home. This may have resulted in essential caregivers being unable to provide residents with assistance with personal care if it was required.

The home sent an email to family members stating that due to the provincial shutdown, the home would temporarily suspend all indoor essential caregiver visits for at least one month.

Not allowing essential caregivers into the home may have impacted the residents mental, physical and spiritual needs thus their quality of life.
