The purpose of this inspection was to conduct a Complaint inspection.

This inspection was conducted on the following date(s): April 20 - 23 and May 3 - 6, 2021.

The following intakes were completed in this complaint inspection:

**Log #003728-21 was related to nutrition and hydration;
Log #004672-21 was related to nutrition and hydration and personal support services.**

During the course of the inspection, the inspector(s) spoke with the Director of Care, the Infection Prevention and Control Manager, the Recreation Manager, the Nutrition Manager, a Registered Dietitian, one Registered Nurse, two Registered Practical Nurses, two Personal Support Workers, one Recreation Aide, one Housekeeper/Laundry Aide, one resident and three family members.

During the course of the inspection, the inspector reviewed two residents' clinical records, the current menu and snack cycles, Resident Food Committee meeting minutes and observed two residents and their rooms, the provision of resident care, the meal and snack services, the homes food cooling area, and infection prevention and control practices.
