1. The licensee failed to ensure the resident's written record is kept up to date at all times.

A review of the flow sheets for the following residents revealed missing documentation related to bathing.

- Resident # 1 was scheduled to receive a bath on Sunday August 5, 2012. A review of the flow sheets under the bathing section revealed documentation for only August 12, 2012. There was no documentation in the progress notes to indicate the resident refused a bath on August 5, 2012.
- Resident #2 was scheduled to receive a shower on Saturday August 4, 2012. A review of the flow sheets under the bathing section failed to reveal documentation the shower was given on August 4, 2012. There was no documentation in the progress notes to indicate the resident refused a bath on August 4, 2012.
- Resident #3 was scheduled to receive a bath on Sunday, August 5, 2012. A review of the flow sheets under the bathing section failed to reveal documentation indicating the bath was given on August 5, 2012. There was no documentation in the progress notes to indicate the resident refused a bath on August 5, 2012.
- Resident #4 was scheduled to receive a bath on Sunday, February 17, 2013. A review of the flow sheets under the bathing sections failed to reveal documentation the bath/shower was given on February 17, 2013. [s. 231. (b)]
