A follow up inspection (2016-539120-0081) was previously conducted on December 27 & 29, 2016, to determine compliance with an order that was issued on April 27, 2016, regarding bed safety. The order was determined to remain outstanding and it was re-issued on January 24, 2017. For this follow up inspection, the conditions that were laid out in the order have been met.

During the course of the inspection, the inspector(s) spoke with the Director of Care, Clinical Director of Nursing and Environmental Services Supervisor.

During the course of the inspection, the inspector toured the 1st and 2nd floors, observed bed systems, reviewed resident bed safety and sleep assessments, residents' plan of care, bed entrapment audit results and bed safety policies and procedures.
