The purpose of this inspection was to conduct a Complaint inspection.

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

- (a) the home, furnishings and equipment are kept clean and sanitary; 2007, c. 8, s. 15 (2).
- (b) each resident's linen and personal clothing is collected, sorted, cleaned and delivered; and 2007, c. 8, s. 15 (2).
- (c) the home, furnishings and equipment are maintained in a safe condition and in a good state of repair. 2007, c. 8, s. 15 (2).

[LTCHA, 2007, S.O. 2007, c. 8, s. 15(2)(a)] The licensee has not ensured that the home, furnishings and equipment are kept clean and sanitary.

The resident's rooms located on the 2 west home area were observed to be very dusty. The heater surfaces were visibly soiled and dusty in most rooms. The window trim in most rooms in 2 West were also very dusty. A resident's night table in #203 was very soiled. The dining room on 2W was observed to have soiled wall surfaces (by hamper station), visible matter on a large cabinet in the room and dusty and soiled heater surfaces. The closet doors in approximately 5 resident rooms on 3E were observed with visible matter on them. The floors in many resident rooms have patches of old floor finishing product on them which have become discoloured over time.
