**The purpose of this inspection was to conduct a Critical Incident System inspection.**

**This inspection was conducted on the following date(s): June 21, 22, 23, 24, 25, 2021.**

**The following intakes were completed as part of this Critical Incident System (CIS) inspection:**

- Log #005186-21, CIS #2684-000003-21, regarding an allegation of staff to resident abuse
- Log #000013-21, CIS #2684-000001-21, regarding an altercation between residents

**During the course of the inspection, the inspector(s) spoke with the Administrator, the Assistant Director of Care, the Quality Improvement Coordinator, the Environmental Services Manager, Registered Nurses, Behaviour Support Ontario (BSO) Registered Practical Nurse, BSO Personal Support Worker, Personal Support Workers, Administrative Assistant, Activity Aide, Housekeeper, and residents.**

**Also during the course of the inspection, a record review was completed of resident healthcare records including behaviour monitoring and careplans, weekly wound care assessments, COVID-19 screening and testing documents, air temperature monitoring logs, internal investigation notes, training records, and Policy #G-20 Hot weather-related illness, reviewed May 15, 2021. Observations were also completed of the entrance of the home including the screening and testing areas for COVID-19, of resident meal service, housekeeping services, designated cooling areas and air temperatures in resident rooms and common areas, and of the provision of resident care and services.**
