Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6. Plan of care

Specifically failed to comply with the following:

s. 6. (7) The licensee shall ensure that the care set out in the plan of care is provided to the resident as specified in the plan. 2007, c. 8, s. 6 (7).

Findings/Faits saillants :

1. The licensee has failed to comply with LTCHA, 2007 s. 6 (7) whereby care set out in the resident plan of care was not provided to the resident as specified in the plan.

Resident #1 has a physician order for the daily administration of an identified medication. On three consecutive days, RPN #100 failed to administer Resident #1's medication.

Resident #1 was monitored, the physician and Power of Attorney were notified and blood work was completed. The resident experienced no negative outcomes as a result of the incident. The staff member was reprimanded by the home and all registered staff were required to complete education related to medication administration. [s. 6. (7)]
