The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): April 3 - 4 and May 2, 2017

A Critical Incident System inspection was conducted related to an incident of alleged resident to resident abuse.

During the course of the inspection, the inspector(s) spoke with Administrator, Director of Nursing, Associate Director of Nursing, Resident Assessment Instrument (RAI) Coordinator, a Registered Nurse, two Registered Practical Nurses, four Personal Support Workers, a Physiotherapy Assistant and two residents.

The Inspector also reviewed internal investigation notes, residents' clinical records, staff education records related to Resident Abuse and Mandatory Reporting, relevant policies and procedures, observed staff/resident interactions and provision of care.
