The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): December 28, 29, 2017 and January 02 and 03, 2018

Five Critical Incidents were inspected during the inspection. Logs #021681-17, #022659-17, #024699-17, #023644-17 and #029500-17 related to resident to resident alleged sexual abuse.

During the course of the inspection, the inspector(s) spoke with the Administrator, Registered Nursing Staff, the behavioural Support Ontario staff member (BSO), Personal Support Workers (PSW) and residents.

The inspector observed the provision of care and services to residents, observed staff to resident interactions, observed resident to resident interactions, observed residents' environment, reviewed resident health care records and reviewed home policies.
