The purpose of this inspection was to conduct a Complaint inspection.

This inspection was conducted on the following date(s): March 4, 5, 6, 7, 11, 12, 13, 14 and 18, 2019

The following inspections were conducted:

- Log # 009362-17: a complaint related to resident skin and wound care, nutrition and hydration, weight loss, housekeeping services and care planning
- Log # 020916-18: a critical incident (# 1160-000016-18) related to a incident that causes an injury for which the resident is taken to hospital and which results in a significant change in the resident's health status
- Log # 021619-18: a complaint related to resident nutrition and care plan, reporting of critical incidents, alleged incident of staff to resident abuse, maintenance of equipment as well as emergency measures.
- Log # 024721-18: a complaint related to administration of medication, pain management, air temperature and staffing.

During the course of the inspection, the inspector(s) spoke with the home's Administrator, Director of Care, a Physician, several Registered Nurses (RNs), several Registered Practical Nurses (RPNs), several Personal Support Workers (PSWs), several Dietary Aides, the Activity Director, the home's Administrative Clerk, as well as to several residents.

During the course of the inspection, the inspector reviewed several resident health care records, reviewed several critical incident reports, reviewed medication administration records, observed resident care and services, observed breakfast and lunchtime meal services on March 5-6-7, 2019, observed provision of collation and beverages, reviewed the therapeutic texture menu, reviewed the maintenance logs for nursing care equipment, reviewed CPR staff training, and air temperature.
