WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 66. Designated lead

Specifically failed to comply with the following:

s. 66. (2) The designated lead must have,

- (a) a post-secondary diploma or degree in recreation and leisure studies, therapeutic recreation, kinesiology or other related field from a community college or university; and O. Reg. 79/10, s. 66 (2).
- (b) at least one year of experience in a health care setting. O. Reg. 79/10, s. 66 (2).

Findings/Faits saillants :

1. The licensee has failed to comply with O.Reg 79/10, s. 66. (2) (b) in that the designated lead for the recreational and social activities program does not have at least one year of experience in a health care setting.

On March 14, 2014 during an interview with the Activation Director he indicated that he was hired into the role as the home's designated lead for recreational and social programs sometime in early 2013. The Activation Director confirmed that he did not have any experience in a health care setting at the time of hire.

On March 14, 2014 during an interview with the Administrator he confirmed that the Activation Director was hired sometime in early 2013 as the designated lead for recreational and social programs. The Administrator confirmed that the Activation Director did not have any health care setting experience of at least one year prior to the commencement of employment.
